## **Purpose**

#### Terms and Conditions:

The duration of this agreement will remain valid for a period of five (5) years and become effective upon the date of signature by both parties. Amendments can be made by the mutual consent of both parties. This agreement may be terminated by either party with advance written notice of at least thirty(30) days. Upon notice of termination both parties agree to work in good faith to visiting faculties and students to educate them in respective fields by the termination. The agreement may be extended by the mutual consent of the two parties after the five-year period and it must be renewed in writing.
